POSITIONS IN ACADEMIC ADMINISTRATION:

Chief Operating Officer and Provost, Higher Colleges of Technology, United Arab Emirates. (2009 to 2013). The HCT is a system of 17 college campuses located throughout the Emirates. The mission of this system is to prepare citizens for professional careers in technical fields such as engineering, computer science and allied health. The colleges offer 38 bachelor's degrees and 6 associated master's degrees. The colleges are governed by the Federal Government of the UAE, and are under the office of the Minister of Higher Education and Scientific Research. Accomplishments included increased effectiveness/efficiency of operations; 20% enrollment growth and international accreditation of all major programs of study (ABET, NCATE, AACSB, etc).

Chancellor, Los Angeles Community College District (June, 1999 – 2004; 2007-2009.) Chancellor and Chief Executive Officer of the Los Angeles Community College District, the largest community college district in the nation and includes nine colleges with a budget of $\frac{3}{4}$ billion dollars serving approximately 140,000 students. During my first term, the District passed two of the largest facilities bonds (\$2.2 billion dollars total) ever passed by a community college. Upon my return to the office in 2007 an additional \$5 billion issue was approved. In addition, during my tenure, the District has brought in over \$500 million in external funding, and the 10 foundations are growing at double-digit rates.

Chancellor, California Community College System (January 2004 – June 2007). The Chancellor is the chief state officer in charge of all regulatory policy and budget. Approval of all programs and degrees, budget requests to the Governor and legislature, and all student aid are managed by the State Chancellor and a staff of over 400 working in the State Capital. Relations between the other segments of public and private education, the colleges and the state government, and relations with the Federal Government are managed by the Chancellor. The Chancellor reports to a Governing Board of 17 individuals appointed by the Governor.

President, Eastern Washington University (1989-1998) President and Chief Executive of Eastern Washington University, a public university serving approximately 8,000 students at the graduate and undergraduate levels. Annual capital and operating budget is in excess of \$100 million. Major achievements include increasing the university endowment from under \$1 million to approximately \$28 million; increasing the level of grants and contracts tenfold; raising private and public funds to restore a historical performing arts

center, securing funds to build a new 160,000 square foot library, and to do other extensive renovations. Led the effort to restructure the colleges to better utilize extension and other college/university partnerships (including public/private). Stabilized and guided the building of a quality NCAA Division I sports program.
Total new construction during my tenure exceeded \$400 million.
